**1. INTRODUCTION**

The purpose of this document is to provide you with the information on the resolutions to be proposed at the Annual General Meeting relating to (i) the granting of the Share Issue Mandate and the Repurchase Mandate to the Directors; (ii) the extension of the Share Issue Mandate by the number of Shares repurchased under the Repurchase Mandate; and (iii) the re-election of retiring Directors.

**2. GENERAL MANDATES TO ISSUE SHARES AND TO REPURCHASE SHARES**

At the annual general meeting of the Company held on 25 May 2017, ordinary resolutions were passed by the Shareholders giving general mandates to the Directors to exercise the power of the Company to repurchase its own Shares in accordance with the Listing Rules and to allot, issue and deal with Shares with an aggregate nominal value not exceeding 20% of the aggregate nominal value of the issued share capital of the Company, as at the date of passing of the resolutions. These mandates will lapse at the conclusion of the Annual General Meeting.

At the Annual General Meeting, separate ordinary resolutions will be proposed to seek the approval of the Shareholders to grant to the Directors general mandates to:

- (i) allot, issue and deal with further Shares up to a maximum of 20% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing of the resolution;
- (ii) repurchase Shares up to a maximum of 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of the resolution; and
- (iii) subject to the passing of the aforesaid ordinary resolutions of the Share Issue Mandate and the Repurchase Mandate, allot and issue new Shares in an amount not exceeding the aggregate nominal amount of the Shares purchased pursuant to the Repurchase Mandate.

A statement explaining the proposed general mandate to repurchase Shares is set out in the explanatory statement in **Appendix I** to this document in accordance with the Listing Rules.

Subject to the passing of the ordinary resolution granting the Share Issue Mandate and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, the Company would be allowed under Share Issue Mandate to issue a maximum of 266,654,000 Shares, representing 20% of the issued share capital of the Company as at the Latest Practicable Date. As at the Latest Practicable Date, the issued share capital of the Company was 1,333,270,000 Shares.

### 3. RE-ELECTION OF RETIRING DIRECTORS

Under item 2 in the Notice, resolutions will be proposed at the Annual General Meeting to re-elect retiring Directors. In accordance with bye-law 99 of the Bye-laws, Mr. Wong Yee Shuen, Wilson and Mr. Chen Wei Wen will retire from office by rotation at the forthcoming annual general meeting. Mr. Wong Yee Shuen, Wilson and Mr. Chen Wei Wen, being eligible, will offer themselves for re-election at the Annual General Meeting.

Pursuant to the code provision set out in paragraph A.4.3 of Appendix 14 of the Listing Rules, any further appointment of independent non-executive director serving more than nine years should be subject to a separate resolution to be approved by shareholders. Notwithstanding that Mr Wong Yee Shuen, Wilson has served as independent non-executive Director for more than nine years, (i) the Board has assessed and reviewed the annual confirmation of independence based on the criteria set out in Rule 3.13 of the Listing Rules and affirmed that Mr Wong Yee Shuen, Wilson remains independent; (ii) the nomination committee of the Company has assessed and is satisfied of the independence of Mr Wong Yee Shuen, Wilson; and (iii) the Board considers that Mr Wong Yee Shuen, Wilson remains independent of management and free of any relationship which could materially interfere with the exercise of his independent judgment. In view of the aforesaid factors and the fact that the experience and knowledge of the relevant individual in the business sectors in which the Company operates, the Board would recommend Mr Wong Yee Shuen, Wilson for re-election at the Annual General Meeting.

In accordance with bye-law 102(B) of the Bye-laws of the Company, Mr. Lai Fulin will hold office until the Annual General Meeting and, being eligible, will offer themselves for re-election.

Pursuant to Rule 13.74 of the Listing Rules, biographical details of Mr. Lai Fulin, Mr. Wong Yee Shuen, Wilson and Mr. Chen Wei Wen are set out in **Appendix II** to this document.

#### **4. ANNUAL GENERAL MEETING**

The Annual General Meeting will be held at 12th Floor, Phase I, Austin Tower, 22-26A Austin Avenue, Tsim Sha Tsui, Kowloon, Hong Kong on Monday, 28 May 2018 at 10:30 a.m.. The Notice is set out on pages 13 to 16 of this document.

A form of proxy for use at the Annual General Meeting is enclosed herein. Whether or not you intend to attend the Annual General Meeting, you are requested to complete the enclosed form of proxy and return it to the Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong as soon as practicable and in any event not less than 48 hours before the time appointed for holding the Annual General Meeting or any adjournment thereof. Completion and return of the form of proxy will not preclude you from attending and voting in person at the Annual General Meeting (or any adjournment thereof) should you so wish.

#### **5. VOTING BY POLL**

The Company would like to inform the Shareholders that pursuant to Rule 13.39(4) of the Listing Rules, any vote of Shareholders at a general meeting must be taken by poll. Therefore, the chairman of the Annual General Meeting will, pursuant to bye-law 70 of the Bye-laws, demand a poll vote on all the resolutions to be proposed at the Annual General Meeting accordingly.

An announcement on the poll results will be published after the Annual General Meeting in the manner prescribed under Rule 13.39(5) of the Listing Rules.

#### **6. RESPONSIBILITY STATEMENT**

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors, having made all reasonable enquires, confirm that to the best of their knowledge and belief the information contained in this circular is accurate and complete in all material respects and not misleading or deceptive, and there are no other matters the omission of which would make any statement herein or this circular misleading.

### 7. RECOMMENDATION

The Board is pleased to recommend the retiring Directors for re-election as set out in **Appendix II** for Shareholders' consideration. The Board also considers that the granting of the Share Issue Mandate and the Repurchase Mandate to the Directors and the extension of the Share Issue Mandate by the number of Shares repurchased under the Repurchase Mandate would be in the interests of the Company and its Shareholders as a whole. Accordingly, the Board recommends you to vote in favour of all the relevant resolutions to be proposed at the Annual General Meeting.

This appendix serves as an explanatory statement given to Shareholders, as required under the Listing Rules in connection with the proposed Repurchase Mandate.

### **1. SHARE CAPITAL**

As at the Latest Practicable Date, the issued share capital of the Company was 1,333,270,000 Shares.

Subject to the passing of resolution no. 4(A) in relation to the Repurchase Mandate as set out in the Notice as an ordinary resolution and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 133,327,000 Shares representing not more than 10% of the issued share capital of the Company as at the date of passing of such resolution.

### **2. REASONS FOR REPURCHASES**

The Directors believe that it is in the best interests of the Company and its Shareholders to have a general authority from the Shareholders to enable the Directors to repurchase Shares in the market. Such repurchases may, depending on market conditions and funding arrangements at that time, lead to an enhancement of the net asset value of the Company and/or its assets and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and its Shareholders.

### **3. FUNDING FOR REPURCHASES**

Share repurchases would be funded entirely out of the Company's available cash flow or working capital facilities which will be funds legally available for the purpose as well as in accordance with the memorandum of association of the Company, Bye-laws and the Companies Act. The Companies Act provides that the amount of capital paid in connection with a share repurchase may only be paid out of either the capital paid up on the relevant shares, or the funds of the Company that would otherwise be available for dividend or distribution or out of the proceeds of a fresh issue of shares made for the purpose. The amount of premium payable on a repurchase may only be paid out of either the funds of the Company that would otherwise be available for dividend or distribution or out of the share premium account of the Company.

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited consolidated financial statements contained in the annual report of the Company for the year ended 31 December 2017) in the event that the proposed share repurchases were to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or its gearing levels which, in the opinion of the Directors, are from time to time appropriate for the Company.

#### 5. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the power of the Company to make repurchase pursuant to the Repurchase Mandate in accordance with the Listing Rules and the laws of Bermuda.

#### 6. DISCLOSURE OF INTERESTS

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their associates (as defined in the Listing Rules), have any present intention to sell any Shares to the Company or its subsidiaries under the Repurchase Mandate if such is approved by the Shareholders at the Annual General Meeting.

No connected persons (as defined in the Listing Rules) have notified the Company that they have a present intention to sell Shares to the Company, or have undertaken not to do so, in the event that the Repurchase Mandate is approved by the Shareholders.

**7. TAKEOVERS CODE AND MINIMUM PUBLIC HOLDING**

If as a result of a repurchase of Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert (within the meaning under the Takeovers Code) could, depending on the level of increase in the Shareholders' interest, obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, Mr. Lai Guanglin, the controlling shareholder of the Company, has an indirect interest in 437,234,620 Shares representing approximately 32.79% of the issued share capital of the Company and Mr. Yu Ben Ansheng, an Executive Director and Chief Executive Officer of the Company, has a direct and indirect interest in 149,000,000 Shares representing approximately 11.18% of the issued share capital of the Company. In the event that the Directors exercise in full the power to repurchase Shares which is proposed to be granted pursuant to the Repurchase Mandate, then (if the present Shareholders' interests in Shares remain the same) the attributable shareholding of Mr. Lai Guanglin and Mr. Yu Ben Ansheng would be increased to approximately 36.44% and 12.42% of the issued share capital of the Company respectively. Such increases will not give rise to an obligation to make a mandatory offer under Rules 26 and 32 of the Takeovers Code.

The Directors are not aware of any consequences which would arise under the Takeovers Code as a result of any repurchases of Shares pursuant to the Repurchase Mandate.

The Directors do not intend to exercise the power of the Company to repurchase Shares pursuant to the Repurchase Mandate to the extent that would render the aggregate amount of the issued share capital of the Company in the public hands to less than 25%.

**8. SHARE PURCHASE MADE BY THE COMPANY**

The Company has not purchased any Shares (whether on the Stock Exchange or otherwise) in the six months preceding the Latest Practicable Date.

The biographical details of Directors who are proposed to be re-elected at the Annual General Meeting are set out below for Shareholders' information.

### **MR. LAI FULIN**

*Executive Director and Chairman*

Mr. Lai, aged 52, was appointed as an Executive Director of the Company in October 2009 and retired from the Board in May 2017 but continued to sit on the senior management team of the Group thereafter. Mr. Lai rejoined the Board as an Executive Director of the Company on 27 November 2017 and has been appointed as the Chairman of the Board, the Chairman of the Nomination Committee and a member of the Remuneration Committee of the Company with effect from 30 March 2018. Mr. Lai is also the Head of Production & Purchasing of the Group and holds directorships in certain subsidiaries of the Company. Mr. Lai has over 20 years of experience in the banking sector, investment management and general management of companies in China. Mr. Lai worked in the Bank of China in Shenzhen from 1986 to 2001. From 1995 to 2001, he was the deputy general manager of a subsidiary of Bank of China dealing with businesses in the securities industry. During the period from 2002 to 2008, Mr. Lai was the general manager of 深圳市華奧冠力科技實業有限公司 (Shenzhen Huao Guanli Technologies Company Limited\*). Mr. Lai holds a certificate of graduation in Chinese Language from 深圳教育學院 (Shenzhen Institute of Education\*).

Mr. Lai is the younger brother of Mr. Lai Guanglin, the controlling shareholder of the Company, the former Executive Director and Chairman of the Board.

Mr. Lai has entered into a letter of appointment with the Company with no specific term. He is subject to retirement by rotation and re-election at the general meetings in accordance with the bye-laws of the Company. Mr. Lai is entitled to receive a basic salary in the amount of HK\$1,758,000 per annum, other benefit and discretionary bonus which are determined by reference to his duties and responsibilities, experience, the prevailing market conditions and the financial results of the Group.

As at the Latest Practicable Date, Mr. Lai has personal interests in share options to subscribe for 5,000,000 shares in the Company.

Save as disclosed above, as at the date of this announcement, Mr. Lai (i) did not hold any directorship in any other publicly listed companies in the last three years; (ii) does not hold any other major appointments or qualifications; (iii) does not hold other positions in the Company or other members of the Group; (iv) is not connected with any directors, senior management or substantial shareholders or controlling shareholders of the Company; and (v) does not have any interests in any securities of the Company within the meaning of Part XV of the SFO.

Save as disclosed above, there is nothing in respect of Mr. Lai which needs to be disclosed pursuant to Rule 13.51(2)(h) to (v) of the Listing Rules nor is there anything which needs to be brought to the attention of the Shareholders in connection with his re-election.

### MR. WONG YEE SHUEN, WILSON

*Independent Non-executive Director*

Mr. Wong Yee Shuen, Wilson, aged 50, was appointed as Independent Non-executive Director of the Company in February 2009. He is also the Chairman of the Audit Committee of the Company. Mr. Wong is a fellow member of the Hong Kong Institute of Certified Public Accountants and member of Australia CPA and Australian Institute of Banking and Finance. He holds a master of commerce degree, specializing in banking and finance from the University of New South Wales. With more than 20 years of experience in PricewaterhouseCoopers and Ernst and Young, Mr. Wong specializes in the area of auditing banks and listed companies. Mr. Wong is currently the chief financial officer of China Animation Characters Company Limited (Stock code: 1566, a company listed on The Stock Exchange of Hong Kong Limited “HKSE”). He served as independent non-executive director of Ping An Securities Group (Holdings) Limited (Stock code: 231, a company listed on HKSE) from 17 November 2015 to 1 December 2017. Mr. Wong has been appointed as an independent non-executive director of PT International Development Corporation Limited (Stock code: 372, a company listed on HKSE) on 6 November 2017.

Mr. Wong has entered into a service contract with the Company for a term commencing from 1 January 2018 to 31 December 2018. He is subject to retirement by rotation and re-election in accordance with the Bye-Laws. Mr. Wong is entitled to a director’s fee of HK\$200,000 per annum and share based payment which are determined by reference to his duties and responsibilities, experience and the prevailing market conditions.

As at the Latest Practicable Date, Mr. Wong has interests in 1,000,000 share options in the Company within the meaning of Part XV of the SFO.

Save as disclosed above, as at the date of this announcement, Mr. Wong (i) did not hold any directorship in any other publicly listed companies in the last three years; (ii) does not hold any other major appointments or qualifications; (iii) does not hold other positions in the Company or other members of the Group; (iv) is not connected with any directors, senior management or substantial shareholders or controlling shareholders of the Company; and (v) does not have any interests in any securities of the Company within the meaning of Part XV of the SFO.

### MR. CHEN WEI WEN

*Independent Non-executive Director*

Mr. Chen Wei Wen, aged 49, was appointed as Independent Non-executive Director of the Company in April 2010. He is also a member of the Audit Committee, Nomination Committee and Remuneration Committee of the Company. Mr. Chen holds a Bachelor of Business (Accounting) from Monash University, Australia. Mr. Chen worked as a general manager of Guangzhou Futian Trading Company Ltd (廣州市富添貿易有限公司) from 1997 to 2005. Since November 2004, Mr. Chen was appointed as chief operating officer of Guangzhou Kanxin Polymer Technology Co., Ltd (廣州市康心高分子科技有限公司) which is an affiliated company of Guangzhou Futian Trading Company Ltd (廣州市富添貿易有限公司). Mr. Chen was also appointed as director and general manager of Fuda Enterprises Limited (富而達企業有限公司) since February 1998.

Mr. Chen has entered into a service contract with the Company for a term commencing from 1 January 2018 to 31 December 2018. He is subject to retirement by rotation and re-election in accordance with the Bye-Laws. Mr. Chen is entitled to a director's fee of HK\$150,000 per annum and share based payment which are determined by reference to his duties and responsibilities, experience and the prevailing market conditions.

As at the Latest Practicable Date, Mr. Chen has interests in 1,000,000 share options in the Company within the meaning of Part XV of the SFO.

Save as disclosed above, as at the date of this announcement, Mr. Chen (i) did not hold any directorship in any other publicly listed companies in the last three years; (ii) does not hold any other major appointments or qualifications; (iii) does not hold other positions in the Company or other members of the Group; (iv) is not connected with any directors, senior management or substantial shareholders or controlling shareholders of the Company; and (v) does not have any interests in any securities of the Company within the meaning of Part XV of the SFO.
