CHANGE OF COMPANY NAME

The Board is pleased to announce that the English name of the Company has been changed from “China Pipe Group Limited” to “Softpower International Limited” and the secondary name of the Company has been changed from “中國管業集團有限公司” to “冠力國際有限公司”.

Reference is made to the announcement of China Pipe Group Limited (now known as Softpower International Limited) (the “**Company**”) dated 9 October 2015 and the circular of the Company dated 20 October 2015 (the “**Circular**”) in relation to the Change of Company Name. Capitalised terms used in this announcement shall have the same meanings as defined in the Circular unless the context herein requires otherwise.

CHANGE OF COMPANY NAME

The Board is pleased to announce that the English name of the Company has been changed from “China Pipe Group Limited” to “Softpower International Limited” and the secondary name of the Company has been changed from “中國管業集團有限公司” to “冠力國際有限公司”.

Subsequent to the passing of a special resolution in relation to the Change of Company Name by the Shareholders at the SGM held on 13 November 2015, the Certificate of Incorporation on Change of Name and the Certificate of Secondary Name have been issued by the Registrar of Companies in Bermuda certifying the change of the English and Chinese names of the Company to “Softpower International Limited” and “冠力國際有限公司” respectively, both with effect from 17 November 2015.

The Registrar of Companies in Hong Kong have also issued the Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company on 8 December 2015 certifying the new names of the Company have been registered in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).
